

Carolina Resource Center for Eating Disorders Summer in the City Raffle Terms & Conditions:

1. VOID WHERE PROHIBITED BY LAW AND OUTSIDE THE UNITED STATES.
2. Carolina Resource Center for Eating Disorders ("CRCforED") is incorporated as a 501 (c) (3) nonprofit corporation under the laws of the State of North Carolina. The CRCforED Summer in the City Raffle ("Trip Raffle") is conducted for the purpose of generating operating funds, and is subject to all applicable federal, state, and local laws, regulations, and ordinances.
3. Limit of 500 tickets will be sold. Tickets may sell out before the date of the raffle drawing. Odds of winning are based on the number of tickets sold up to 500. Ticket purchases are non-refundable and are not tax deductible.
4. Winner must be over 18 years of age and need not be present to win. Present CRCforED employees, Board Members or Fundraising Committee members and any immediate family members residing with employees, Board Members or Fundraising Committee members are not eligible to participate.
5. Ticket sales will end at 5 PM EDT on Friday, July 30, 2021. Winner will be selected at random and announced on all CRCforED social media platforms on Friday, July 30, 2021 at approximately 7 PM EDT. Winner will be notified by telephone, mail and/or email. If the potential winner cannot be reached after 10 days from first notification attempt, or if an entrant is found to be ineligible, or a prize notification is returned as undeliverable, such prize will be forfeited and an alternate winner will be selected by random drawing.
6. Downtown condo dates are August 27 and August 28, 2021 (2 nights). Alternate dates may be selected based on condo availability and must be arranged directly thru Banjoe Vacations. Alternate condo dates must be booked no later than August 15, 2021. If the winner cannot go on selected dates the package may be given away at the winner's discretion. Reselling the winning trip is not permitted.
7. Tubing and tour reservations are subject to availability. Black-out dates and holiday restrictions may apply. Once booked all applicable cancellation fees will apply.
8. Prize package is valued at approximately \$1,550. There is no cash value to the prize, whether in part or whole value. All gift certificates should be handled with care as they are non-replaceable and non-refundable. CRCforED is not responsible for lost, stolen or misplaced gift certificates.
9. Some additional costs could apply, including taxes, and will be the responsibility of the winner. The winner may add to the package and customize the trip in any way at additional cost to the winner.
